Wales Road Casualty Reduction Partnership

INTRODUCTION

Overall responsibility for GoSafe, the Wales Road Casualty Reduction Partnership (WRCRP) is taken by the Partnership's Steering Group. The group oversees all aspects of the Partnership work.

GoSafe is the largest casualty reduction partnership in the UK, comprising 28 equal partners, the Welsh Assembly Government, 22 unitary authorities in Wales, the four police forces and Her Majesty's Court and Tribunal Service and in addition they work very closely with the four Regional Transport Consortia Road Safety Groups. The partners work together to bring about an integrated approach to improving road safety with the continued aim to reduce casualties on the roads in Wales.

The group has delegated day to day responsibility for the operation of the scheme to the Partnership Manager who is supported by employees within the management office and additionally by the Central Ticket Office Managers.

GENERAL INFORMATION

Wales Road Casualty Reduction Partnership is not a public authority as outlined in the Freedom of Information Act 2000 (this has been recognised by the Information Commissioners Office)

WRCRP was formed on April 1st 2009 by merging the Mid & South Wales Safety Camera Partnership and Arrive Alive, the North Wales Road Casualty Reduction Partnership which were the former Safety Camera partnerships dating from 2000 and 2002.

Whilst the Wales Road Casualty Reduction Partnership is not a corporate body, we are made up of public bodies and as such comply with the policies of individual member organisations; we will assist enquirers looking for data by pointing them towards the public authority who hold that data.

Information listed in the scheme will be made available in a number of ways. It may not necessarily be available in all of these ways:

Website: As far as possible information will be made available on our website. Links will be provided from our website to other related websites. Provision of the information on any linked site is the responsibility of that organisation.

By Post: Information will be posted on request. Please use the contact details below to send your requests. We do not provide print-outs from other organisations' websites and any documentation posted could be subject to disbursement costs.

By e-mail: We will receive requests by e-mail, however when a requestor requires certain information that is not available in electronic form, the requestor will then be required to supply a postal address. This is the only process that will allow the Partnership to forward non-electronic published information to a requestor.

COST FOR INFORMATION SUPPLIED

Generally there will be no charges for the provision of information. However, The Freedom of Information Act 2000 does allow public authorities to quantify the work to provide the information and implement specific charges.

If the public authority estimate the requested information is not reasonably available and will require 18 hours or more to process and research, they may not provide the information (s.12(1) Freedom of Information Act 2000), and will write and notify the applicant accordingly. The refusal notification will advise the applicant of potential options that may include payment of a fee which the individual applicant may wish to consider.

ACCESS TO PERSONAL INFORMATION UNDER THE DATA PROTECTION ACT 1998

The Freedom of Information Act 2000 operates in tandem with the Data Protection Act 1998. The Data Protection Act still protects individual rights in relation to the release of personal information. It is however, vital for us to distinguish requests made under the terms of the Data Protection Act 1998 and those made under the Freedom of Information Act 2000. Should a request be made for a copy of any personal data held about an individual then this is a 'subject access request' and all such enquiries will be referred to the Data Protection Officer. COMPLAINTS PROCEDURE

If you are not satisfied with the way your request has been handled, and/or with the decision and reasons not to disclose all or part of the information requested, you have the right to appeal.

Initially your complaint will be re-considered by the official who dealt with your request for information. If, after careful consideration (of the original request and any additional information supplied), that official decides that his/her decision was correct, your complaint will automatically be referred to the Reviewing Officer who will conduct a further review. Should our internal complaints procedure fail to satisfy, you will be provided with information regarding how your complaint can be pursued further.

The Information Commissioner is responsible for enforcing the operation of the publication scheme. In cases of a failure to deliver information through the scheme, you may appeal directly to the information Commissioner at any time.
